CALL TO ORDER - ESTABLISH OUORUM A.

Commissioner Gaines called the meeting to order at 5:37 PM. Present were Commissioners Gaines, Hartsfield, and Lua. A quorum was established.

Also present were Clerk of the Board and Executive Assistant Lefrancois, Directors Bergmann and Daniels, and Judy Friedman, Recording Secretary.

B. APPROVE MINUTES OF MARCH 25, 2009 MEETING

Commissioner Hartsfield asked that "materials" be added after "collateral" in Section 1 paragraph 2. Motion made by Commissioner Hartsfield, second by Commissioner Lua and carried unanimously, to approve the minutes as amended.

E. OLD BUSINESS

1. Update from District Staff (Commission Questions of Report)

Park and Facilities Manager Long submitted a written report for review.

Executive Assistant Lefrancois reported the boat launch might not open this year due to the low lake level, which will result in a reduction in staff. There could be a financial impact to Tahoe Vista Recreation Area (TVRA) because launch fees are the only revenue. She reviewed the TRPA regulations for launching boats and noted that options for installing gates at the launch areas are being considered.

The Commissioners discussed the transition of the operation of Kings Beach State Recreation Area (KBSRA) from the District to California State Parks effective January 1, 2010 and the improvements the State is planning. The transition team will consider options for parking for the Event Center.

EA Lefrançois reported 17 pallets of pavers have been received. Installing them as park pathways will be a training opportunity for new staff.

2. Friends of the Park Fund

EA Lefrançois is still following up on the action items assigned to her. Commissioner Gaines asked about the procedure for writing checks from the Fund and EA Lefrancois explained that the District writes checks and them submit the receipts to the Truckee Tahoe Community Foundation (TTCF) for reimbursement.

followed regarding thanking donors and other fundraising campaigns that can capitalize on the current momentum for the playground. Commissioner Lua is compiling information for a presentation to service clubs and asked for suggestions.

EA Lefrancois was asked to submit a request for funding for TVRA to Placer County. Discussion followed regarding potential avenues of funding.

Commissioner Hartsfield reported on the Committee meeting do consider priority items identified in the Recreation Master Plan. He reviewed a written report. It was noted that any projects related to KBSRA have been tabled because of the transition to State Parks.
