## North Tahoe Public Utility District Seeks New Recreation and Parks Commissioners

(Tahoe Vista, California) - Are you a resident or business owner within the North Tahoe Public Utility District (NTPUD) boundaries interested in parks and recreation looking for an opportunity to serve your community? The NTPUD Board of Directors is recruiting members to volunteer and serve on the District's Recreation and Parks Commission. The Commission consists of five (5) adult members and two (2) student members. Currently there are one (1) adult seat, two (2) youth seats and up to two (2) alternate seats open to be filled.

There are currently significant discussions taking place in the area of recreation and parks. Addressing recreation funding challenges, the proposal for a public-private partnership for the North Tahoe Event Center and updating the Recreation and Parks Master Plan are just a sampling of the discussions taking place. It's important that community and business members participate in the conversation and help to inform decision-making.

Commission members advise, assist and make recommendations about policies, pricing and park rules. They serve as an initial sounding board between District Board of Directors and community members, share feedback from their respective communities with the Board and award Youth Trust Fund scholarships.

NTPUD Recreation and Parks Commission meetings are typically held on the 4th Thursday of the month and are open to the public. The next meeting will be held on Thursday, March 24, 2016 beginning at 5:30PM at the North Tahoe Event Center in Kings Beach. Meetings typically last two to three hours. Commissioners are also asked to commit additional time to support and

promote other Commission activities and events such as the SnowFest Pancake Breakfast and Friends of the Park fundraisers.
