d) **Proof of Primary Residency** – Residential applicants may be required to provide proof of primary residency upon request by the NTPUD.

How to Apply

1. Fill out the application, read the “Important Information” statement and sign and date the application.
2. Attach the required employment loss, relief program, or COVID-19 impact documents. Applications submitted without complete documentation cannot be processed.
3. The program is administered on a first-come first-serve basis. Applicants are encouraged to submit applications early. Program in effect until program funds are fully expended or **June 1, 2021** whichever comes first.

IMPORTANT INFORMATION – PLEASE READ BEFORE SIGNING

I, the undersigned, under penalty of perjury of the laws of the State of California do hereby declare and certify:

- That I have read and understood all of the 2020 Temporary Utility Rate Relief Credit Program Guidelines provided with this application and that all of the information provided by me on this application is accurate, complete, and true to the best of my knowledge.
- That I understand that submitting the required documentation does not guarantee participation in the program. Such information will, however, be used to determine if I qualify for benefits under the program.
- That I understand the rate credit is one time only.
- That I understand the credit will be applied to the account. In the event I am not the account holder of record, the NTPUD encourages the account holder of record/landlord and tenant to work together to provide a rent or similar credit to the tenant qualifying for the program.
- That I understand that any attempt to falsify my information will result in my disqualification from the program and may subject me repayment of the benefits received and further civil or criminal penalties.
