In recognition of the time and energy that Meera Beser has donated to the community to service organizations and causes at the North Tahoe Event Center including the Tahoe Community Thanksgiving, Winter Warmth and Wellness Program, and the US Marine Corps Toys for Tots distribution. The Board presented the Resolution to Meera and thanked her for her service.

- Adopted Resolution 2016-04 to authorize recording of District Board Meetings. This action will allow the District to move forward with the videoing of District Board meeting as was adopted at the last meeting.
- Appointed Alex Mourelatos to the Recreation and Parks Commission. Mr. Mourelatos has been serving as an alternate on the Commission and at the last meeting agreed to move forward as a full member. The Commission is still seeking two (2) Youth Commissioners, one (1) Adult Commissioner and up to two (2) Alternate Adult Commissioners.
- The Board of Directors will join the Recreation and Parks Commission for a Joint Meeting on Thursday, February 25, 2016 to hear a presentation from Laulima Development LLC on their proposal for a public-private partnership related to the North Tahoe Event Center.
- Authorize budget adjustments related to the Board action taken in December to strategically re-allocate costs and provide financial stability to the Recreation and Parks Department for the remainder of the 2015-2016 budget. These budget adjustments will provide direction to staff when developing the 2016-2017 budget. Direction was also given to solicit proposals for a needs assessment for recreation to provide data for master planning and strategic solutions for recreation funding.

The next regular meeting of the NTPUD Board of Directors will be held on Tuesday, March 8, 2016 beginning at 2:00 pm at the North Tahoe Event Center in Kings Beach. NTPUD board meetings are open to the public and all are invited to attend.
