The Board appointed Lydia Carter of Kings Beach, and Bob Hartsfield of Carnelian Bay and Mandy Lua of Tahoe Vista, to serve as Commissioners.

We thank them for their willingness to step forward and to be a liaison between the Board and the Community on the matter of Recreation and Parks. The Commission and the District have an exciting year ahead as we replace and upgrade our playground facilities and work to strengthen the Friends of the Park Foundation.”

Lydia Carter has been with East West Partners for over 5 years. Recently, Lydia has been involved with Friends of the Park as a grant writer for the playground equipment. As a mother of 2, she is particularly passionate about upgrading the playground areas of the Park as well as expanding recreational programming for all local youth.


Mandy would like to see recreation expanded for all age groups. She hopes to use her employment with the NTBA as a link between the Parks and Recreation Commission and local businesses.

The Recreation and Parks Commission is comprised of a group of interested citizens whose function is to provide advice, assistance and recommendations to the North Tahoe Public Utility District Board of Directors and to facilitate communications between the Board and the community in matters relating to Recreation and Parks Services and Facilities. The Commission meets monthly at the North Tahoe Community Conference Center. The next meeting is Wednesday, January 28, 2008. Meetings are typically held on the fourth Wednesday of every month, but are subject to change due to the schedules of the Commission. The agenda for the meetings are posted at the three local post offices (Kings Beach, Tahoe Vista, Carnelian Bay) as well as on the NTPUD website, www.ntpud.org. The District is always accepting applications for adult Commissioners as well as the two Youth seats on the Commission which are currently open and being recruited.
